Product description and its intended use:

Hallmark Veneer produce decorative timber veneer panel from a wide range of species for the production of veneer panel and doors. The veneer itself is a timber layer 0.6mm thick which is pressed onto a substrate (usually MDF or Ply). Numerous cutting and matching options are available to affect unique aesthetic outcomes.

Statement on how the building product is expected to contribute to compliance:

B2 DURABILITY - B2.3.1 (c):

Hallmark Veneer has a durability beyond 5 years when correctly installed and maintained, based on historic use in-market for more than 30 years.

F2 HAZARDOUS BUILDING MATERIALS: F2.3.1

Hallmark Veneer is manufactured using inert, nontoxic materials.

Limitations on the use of the building product:

- Hallmark Veneer is for interior use, and must not be exposed to high levels of direct sunlight or large fluctuations in humidity. Veneer is a natural product, like all timber products it may fade or discolour over time in areas exposed to high levels of light, heat and air.
- This range is not suitable for use damp areas or exterior applications, as a flooring product or as kitchen counter top or splashback.
- Veneer panel used in kitchen and bathroom situations needs to be properly edge banded and sealed to ensure there is no moisture egress into the product, proper ventilation in these areas is also important.
- If used in a high wear area, suitable finishing systems must be used as advised by an experienced coatings professional.
- Veneer being a natural product, there will always be a level of feature that is specific
 to each specie; this could be pin knots, gum vein, small indentations, slanted and
 curved direction of grain in Quarter Cuts, off centre crown in crown cuts and paling
 fence effect in some ¼ cuts especially when stains are used as part of the finishing
 process. These are not defects but intrinsic features of natural wood veneer and its
 processing.

Design requirements that would support the use of the building product:

Hallmark Veneer Range is designed for, but is not limited to, use in projects within the following scope:

- Housing and residential apartment buildings, and their associated ancillary and outbuildings interior use only.
- Commercial buildings, and their associated ancillary and outbuildings interior use only.

Hallmark Veneer Range may be used in projects outside this scope if other parties such as architects or specifiers establish appropriate design and installation requirements.

Installation requirements:

- Installation requirements vary depending on intended use.
- Doors and panel must be stored flat in a clean, dry area away from direct sunlight. A
 flat MDF cover sheet must be placed on the surface at all times should it be
 exposed.

- Inspect product upon arrival for freight damage and visible defects. Hallmark must be notified within four days if damage has occurred. Any claims outside of this time frame cannot be recognised.
- Hallmark Veneer Panel and Doors must be installed in dry buildings only. Installation in situations with excessive air movement (i.e. buildings not at 'lock up' stage) void the warranty.
- It is essential that the right coating system is used, for example, two pack acrylicurethane products with approved UV prohibitors for sealer and top coats.

Maintenance requirements:

• Veneer that becomes scratched or damaged should have the coating repaired immediately. Any repair work must be carried out under the instructions of the coating manufacturer.
